# **Public Information Coordinator Report**

It's usually a little challenging to find events coming up for November and December, simply because there isn't a whole lot happening radio wise. This is the time of year where fall starts to turn to winter (whether we want it to or not – mostly "or not") and we begin planning family events for the holidays. How those events look is different for all of us because we all have our own traditions and they're all beautifully unique. That said, there are some events that do happen between November and December, and here's a short rundown of some stuff that may be of interest.

Sunday, November 2 is the Fox Cities Amateur Radio Club's Hamfest. It will be at the Sunnyview Expo Center in Oshkosh, and runs from 8:00 a.m. to 1:00 p.m. They'll have VE testing, raffle prizes, food and beverage available and informational presentations by subject matter experts. ## **Supporting the Next Generation: ARRL Foundation Scholarships**

As the season for scholarship applications approaches, it's an opportune time to highlight the scholarships offered by or supported by the ARRL. Many amateur radio scholarships remain unclaimed or are awarded to the same individuals multiple times, so please share these scholarships among high school and college students.



#### **ARRL Foundation Scholarship Program Overview**

The ARRL Foundation manages over 100 scholarships, ranging from \$500 to \$25,000, funded by generous donors. These scholarships are available to active, FCC-licensed amateur radio

operators pursuing higher education. The 2026 scholarship cycle is set to open on October 30, 2025, with applications accepted through January 6, 2026. Scholarship recipients are notified in June, and awards are disbursed directly to their educational institutions in July.

### **Highlighted Scholarships**

To provide insight into the types of scholarships available, here are some notable examples:

- The ARRL Scholarship to Honor Barry Goldwater
  - o Amount: \$5,000
  - Eligibility: Licensed amateur radio operator, graduating high school senior or undergraduate student
  - Requirements: Letter of recommendation from an ARRL-affiliated club officer attesting to the applicant's amateur radio activity; intended field of study in communications
- The Amateur Radio Digital Communications (ARDC) Scholarship
  - o Amount: \$25,000
  - o Eligibility: Active amateur radio license for at least one year prior to application
  - Requirements: Three letters of recommendation; minimum GPA of 3.5; open to any field of study and institution; highly competitive with only 20 awards given annually
- The L.B. Cebik, W4RNL, and Jean Cebik, N4TZP Scholarship
  - o Amount: \$5,000
  - Eligibility: Technician Class or higher license
  - Requirements: Enrollment in a 4-year college or university; no specific field of study or GPA requirements
- The Alfred E. Friend, Jr. W4CF Memorial Scholarship
  - o Amount: \$5,000
  - Eligibility: Any active amateur radio license class
  - Requirements: Intended field of study in engineering; no specific GPA requirements
- The Hy and Mimi Ginsberg Memorial Scholarship
  - o Amount: \$4,000
  - Eligibility: Any active amateur radio license class
  - Requirements: Enrollment in a 2-year or 4-year college, university, or trade school; U.S. citizenship required
- The Ronald Hesselbrock, WA8LOW, Memorial Scholarship
  - o Amount: \$10,000
  - o Eligibility: Active amateur radio license for at least one year prior to application
  - Requirements: Enrollment in an accredited U.S. college, university, or trade school; ARRL membership for at least one year; letter of recommendation from a local amateur radio club officer verifying the applicant's activity
- The Ozaukee Radio Club, W9CQO, Scholarship
  - o Amount: \$2.000
  - o Eligibility: Any active amateur radio license

Requirements: Under 26 years old; Wisconsin resident; enrollment in a full-time
 4-year undergraduate program

### **Encouraging Student Participation**

These scholarships represent just a fraction of the opportunities available through the ARRL Foundation. Many scholarships have no preference regarding the type of higher education pursued or the field of study, which allows flexibility for students to choose paths that align with their interests and career goals.

#### Conclusion

By actively supporting and promoting the ARRL Foundation scholarships, we can help ensure that more students have the opportunity to pursue higher education with reduced financial burdens. This not only benefits the individuals but also strengthens the future of the amateur radio community.

The Importance of Messages

FAQ # 290 Are the messages we hear on our nets important? Sure they are. Some might question the value of the messages we relay. It seems to them that the information we transfer isn't of high importance, so why do we bother? Couldn't we just call the recipient with our cell phone? Well, that's the point. We do it for the times that the cell phone *isn't* working.

When we pass someone and say, "Hello," "Good Morning," or "Hot enough for you?" we aren't *really* exchanging much information - but it's important to say those greetings to recognize the other person, to be polite, to test the system.

Before any significant, sizable meeting -- such as a national convention, a large congregation's church service, or a sold-out rock concert -- some sound technician walks up to a microphone and says something like, "Testing. One, two, three. . ." (Or "Czech one, two, three" or "Norwegian, one, two, three" but I digress.) Those words certainly don't carry important information, but it is *extremely* important that they be said. If they're not, how will the technician know if the system is functioning properly? So it is with our nets. We run them to exercise the system - including our equipment, our knowledge, and our skills.

Exercises such as the Simulated Emergency Test, Field Day, a public service event, or daily traffic nets are valuable because of the training they provide. When we test equipment, procedures or ourselves, it makes us a better team for doing what we do.

Is the content of all of our the messages of high importance? Sometimes, maybe not. Is it important that we use those messages for practice? Always. 73 – K9LGU/STM
